Over those many years we have hosted numerous visits from our friends across the sea and we, in turn, have been hosted with welcome arms by our friends from Pinneberg. We are a people-to-people activity. There is no economic basis for our decision to establish our Sister City relationship. There is a huge world out there and we just want to be exposed to more of it - and to enjoy new experiences of language, culture, food - and friendship. Anyone can sit home and watch television all day and gain nothing from the experience. Putting yourself in front of someone who may or may not speak English as well as yourself, and whose lifestyle is markedly different from your own is exciting - and interesting -and adds value to your own life experience.

My point is this, to continue to provide these life-enhancing, even life-changing experiences, people need to take advantage of the opportunities we provide for visits to Pinneberg, and hosting visitors from Pinneberg. We need to broaden our membership base and fund-raising sources so that the program activities we plan and organize are not unduly expensive for those who do participate. We have kept our membership dues low to encourage more participation, but many of those who have participated in exchanges never join or drop their membership after a year or two. We try very hard to provide great experiences for our guests, but meals, travel, admission tickets to events - they all cost money and our treasury is not so large that we can treat everyone who visits us as well as we have been treated by our hosts in Germany - who I might add, spare no expense to engage and entertain us when we pay a visit.

If you have been a passive member of the RSCC, I would encourage you to participate in our activities. Help us remain solvent through your continued membership and at least a few times each year, join us for a wine-tasting ... or other social activity so that you can get to meet and know us better.

We are all volunteers. No one in the RSCC is paid a nickel for anything. We contribute our time, effort, and financial resources to keep the organization running smoothly, and now we have embarked upon a second Sister City relationship that will further expand our reach to the world - and bring opportunity for those who share our vision to engage with their counterparts across the ocean - this time with China.

December 2014 - JIAXING DELEGATES VISIT ROCKVILLE

Jiaxing sent officials to visit Rockville in December. Their mission was to: 1) meet with the City of Rockville Mayor and Council; 2) hold discussions with educational contacts; 3) visit schools in Rockville and explore the possibilities of establishing sister school relations between our two cities; and 4) learn the experiences in fields of administrative supervision and the utilization of public funds.

On Monday, December 15th - after a long ride from New York - a Welcome Reception was held at the Rockville City Hall, and afterwards the delegates had an opportunity to observe a regularly scheduled meeting of the Rockville Mayor and Council.



On Tuesday, December 16th, the delegates met with Rockville school principals at Julius West Middle School. This meeting gave an opportunity for both the Jiaxing delegation and Rockville schools to know more about how the school systems work on each side of the Pacific Ocean.

After lunch, they were given briefings by Rockville City Staff. Both sides learned a lot regarding each other's methods of governing.

At the end of their busy day our guests were honored at a reception/dinner at the Rockville Hilton Hotel. 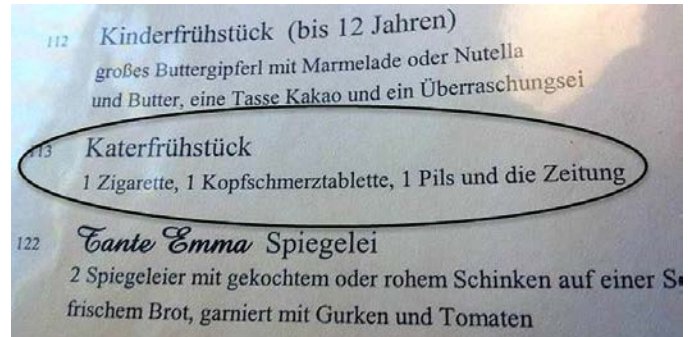


Betsy’s immediate plans are to continue her work with the Ski Patrol, and to put her communication skills to work as a Tour Guide in Washington DC.

March - PINNEBERG STUDENTS DISCUSS TRIP TO ROCKVILLE

Before the annual meeting of the German-American Society Rockville Pinneberg [DAGRP] started, four students of Theodor Heuss school had their say.

Merle Szimkowski, Hermann Siebel, Benita Thiel and Anneke Sellmann reported together with teacher Oliver Grosscurth on their trip to Rockville.

Siebel reported of a friendly welcome at the 3000-student American high school [Wootton] and the host families. "I had a whole floor for me," he said, and also praised the "drivers", the host parents. After the 14-day stay, it was clear changes were

felt: "I think my English has improved. My English teacher thinks that too." Especially memorable to Benita Thiel was a roadblock in Washington, where the group was stopped by police. Minutes later darkened limousines rushed past, including a police escort.

"We cannot prove it, but we are sure that we saw Obama," said the Heuss-student. In the Rockville Room of [Pinneberg's] Town Hall is a similar photo of a sedan with a waving US flag and Presidential Seal on the driver's door. In addition to attractions such as the Capitol, the White House or the Statue of Liberty during a trip to New York, Merle Szimkowski was intrigued by something else: "It was nice to see the daily life of the people and not just tourist attractions." Sellmann brought the opinion of the students to the point: "That was one of the greatest experiences I've had in my young life and we want to once again thank you, that you made it possible." Many contacts with host families are still intact - and the anticipation on a return visit [from Rockville students] was great. In July, six to ten students and two teachers [from Rockville] are expected in Pinneberg.

"It's good to hear something like that. This is an endorsement of our work, when it has such a positive impact," said Bernd Hinrichs, president of the German-American Society Rockville Pinneberg. ...There were 158 members in DAGRP at the end of 2014. "There are 61 couples and 37 individuals. The male to female ratio was, as usual, almost balanced with 81 to 80," Treasurer Hans-Dietmar Bethke said. He resigned his position [as Treasurer] after twelve years. [B]ut he was re-elected by the Society's members as a Board Director to supervise the website. Felicity Lawrence was elected as the new Treasurer. Vice-President Margrit Ziegler was also confirmed in office as were Directors Birgit Drechsler and Michael Patt.

PINNEBERG HISTORY

When a castle was first built in Pinneberg around the year 1200 AD, the site had already been used as a Germanic [Thingstätte](#) for several centuries. In 1370 the castle was captured by Count Adolf VIII of Schauenburg and [Holstein-Pinneberg](#).

In 1397 Pinneberg was first mentioned in official documents as a seat of courts.

In 1472 a Renaissance castle was built in place of the old castle. It was heavily damaged in the years 1627 and 1657 and was finally torn down in 1720. Between 1765 and 1767 the Drostei was built for the [Drost](#) Hans von Ahlefeldt. This brick building, which was probably erected by Ernst Georg Sonnin, is the most important example of Baroque architecture in the district of Pinneberg.

After some servants and craftsmen had settled in the vicinity of the castle, the settlement expanded slowly, only receiving municipal rights in 1875, although it had been the seat of the Danish '[Landdrost](#)' since 1640 and seat of the Prussian district administrator since 1866 within the [Province of Schleswig-Holstein](#).

In 1905 the settlement of 'Pinneberger Dorf' was incorporated and in 1927 the villages of Thesdorf and Waldenau followed.

After World War II the number of inhabitants of Pinneberg doubled because of the [forced immigration of expellees](#), predominantly from [East Prussia](#). Later on, in contrast to many other cities in [Schleswig-Holstein](#), Pinneberg was able to keep the number of inhabitants stable.
